

NOTE:-

1.	Fare	Rs.40/- for 1st kilometer (upon downing the meter) and thereafter RS.17.00 per kilometer for Non-AC Taxis every additional kilometer.
2.	Night charges	25% of the fare (11.00 PM to 5.00 AM)
3.	Baggage charges	Rs.15/- shall be charges per piece, whereas the driver/operator shall not charge any money for a shopping bag or a small attaché/suitcase.
4.	Waiting charges	Rs.01 /- per minute for every minute stuck in traffic or moving extremely slow (less than 1 Km. covered in 10 minutes.)
5.	Service charges	Rs.7% of basic fare per trip as service charge for manning the Pre-paid booth and other recurring expenditures. Besides, 10% incentive is for the Taxi drivers operating from Airport as they return without passenger.

All I/Cs, Pre-Paid Service Booths, Accountants/Pre-Paid Services shall bring the revised service charges to the notice of all the employees working at Pre Paid Services and display the copy of this order prominently at the respective Pre-Paid Services Booths for the knowledge/awareness of commuters opting for the Pre Paid Service facility. It will be the duty of accountants to provide enough change at the Pre Paid Service Booths to cater the daily requirements of change. Any deviation of this order will be viewed seriously.
